2. The last date of online submission of tender is 20/11/2019 upto 15.00 hrs.
3. The date & time of opening of online tender is 22/11/2019 after 15.30 hrs in the office of the **Executive Engineer, Division XVIII(Roads), PWD, Ponda, Goa.**

The online application should accompany the following documents (Scan and Upload original document on the e-Tender website):www.etender.goa.gov.in or <https://www.tenderwizard.com/GOA>.

- a. Original copy of valid Goa PWD Registration Certificate.
- b. Original copy of PAN Card.
- c. Original copy of GST valid registration certificate.
- d. **Copy of the system generated mail/sms from the Commercial Tax Department, Government of Goa showing the latest Application Reference Number (ARN) generated on GST commom Portal www.gst.gov.in after filling the latest return which was due as per GST Law.(For all the works).**
- e. The applicant should submit a declaration for each work separately as per Annexure- A on stamp paper of `.
- f. Eligibility criteria for works pertaining to hiring of Vehicle.
- i). Attested copy of Original Valid Registration Certificate of the vehicle.

- ii). Attested copy of Original PAN CARD issued by the Income Tax Department.
- iii). Attested copy of Original Valid All Goa Permit issued by Goa R.T.O..
- iv). Attested copy of Original Valid fitness certificate.
- v). Attested copy of Original Valid Tax License.
- vi). Attested copy of Original Valid Insurance certificate.
- vii). Attested copy of Original Valid PUC certificate.
- viii). Attested copy of Original Valid GST registration certificate.

F. Mode of payment towards Tender Document Fee (TDF), Tender Processing Fee (TPF) & Earnest Money Deposit (EMD) to be paid online through e-Payment mode via:

- i. National Electronic Fund Transfer (NEFT)/Real-Time Gross Settlement RTGS)/Axis Bank Over-the-counter (OTC). Tenderer requires download pre-printed Challan towards credit of ITG available on e-tender website and make its payment through any of their Bank.
- ii. Internet payment Gateway (Debit/credit card of type VISA, MASTERCARD or Rupay.)
- iii. Net Banking: Payment can be made through the Internet Banking of Any Bank.

Note:- Any Payments made through NEFT/RTGS/OTC will take 24 hours for its reconciliation. Hence the payments through NEFT/RTGS/OTC should be made at least TWO BANK WORKING DAYS in advance before any due date and upload the scanned copy of challans in the e-tender website as a token of payment.

INSTRUCTIONS TO TENDERERS

1. The bidder shall quote the percentage rates for the scheduled Estimated Cost excluding GST and GST as applicable shall be paid extra on total cost of the work done.

2. The intending Tenderer must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.

3. Information and Instructions for Tenderer posted on website shall form part of bid document.

4. The bid document consisting of plans, specifications, the schedule of quantity of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.etender.goa.gov.in or <https://www.tenderwizard.com/GOA>.

5. Those Tenderer not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website. For any of the assistance regarding participation may contact e-tender support staff or email: goatender@gmail.com

6. The intending Tenderer must have / obtain a valid Class-III digital signature to submit the bid.

7. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.

8. The cell meant for quoting rate /percentage in figure appears in sky blue colours (Rupees in words will be automatically taken).

9. It is the responsibility of the Tenderer to ensure the credit of Tender Document Fees, Tender Processing Fees and EMD into the respective receiving bank accounts of ITG via various mode of payments mentioned above, on or before last due date and time of tender.

10. In addition to this, if cell is left blank and no rate/percentage is quoted by the tenderer, the tender will be treated as incomplete tender & will be rejected outright.

11. The Tenderer is required to ensure browser compatibility of the computer well in advance to the last date and time for receipt of tenders. The department shall not be responsible for non-accessibility of the e-Tender portal due to internet connectivity issues and technical glitches at the tenderer's end.

12. The tenderer shall be responsible for the correctness and genuineness of the documents uploaded during the tender submission. Any discrepancies in the matter will be liable for rejection and suitable action.

13. No hardcopies of the documents to be submitted in the tender box. However the lowest Tenderer shall submit the hardcopies of the documents scanned and uploaded and original copy of declaration on stamp paper, after opening of the tender.

14. Tenderer must ensure to quote percentage figure with '+ve' sign for 'above' with '-ve' sign for 'Below' and simply 'Zero' for 'At Par' quote in the cell meant for quoting rate/percentage in figure which appears in sky blue colour (Rupees in words will be automatically taken). Also, name of the Tenderer should be entered in respective cell.

15. The tenders which are quoted more than 20% below the amount put to tender shall be rejected as per circular bearing No.1-8-07/SSW-PWD-Vol.I/2007-08/527,dt.12/11/2007.

The bidders whose close relatives are employed in the Goa PWD are not eligible for work at Sr.No.12. Declaration in format at Annexure-B may be submitted in the respect. (As per Note No.1-1-PCE-EO/2018-19/42 dt.20/8/2018)

Incomplete applications shall be summarily rejected and right to reject any or all the tenders including the lowest without assigning any reason thereof is reserved.
