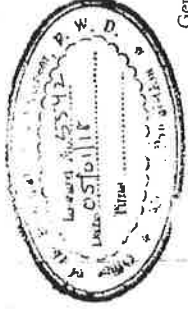

OFFICE MEMORANDUM

In order to enable the Ministers, Speakers, Deputy Speaker and the other dignitaries on whom the status of cabinet Ministers has been conferred, to efficiently efficaciously discharge their duties, the Government has decided to provide certain minimum infrastructural facility at their private residences such as provision for hoisting of National flag, Security cabin and toilet facilities for the visitors.

In this regard, the Government has laid down the following guidelines:-

1. Assets shall be created at private residence of the above mentioned public functionaries only in the interest of the Public, and which shall facilitate the discharge of their official duties.
2. Proposal structure/work of civil nature should be of such a nature and design that it can be dismantled/detached and can be shifted and put to reuse.If the cost of such work is likely to exceed Rupees One Lakh, then prior approval of the General Administration Department shall be obtained and the work shall be executed through the Public Works Department.
3. Such facilities will be continued till the aforesaid dignitaries continue to hold their office. Once the dignitaries cease to hold the office or demit his/her office, the facilities so provided shall be discontinued and the structure created shall be dismantled wherever possible. The structure/asset shall be left as it is if removal is either not feasible or uneconomical. The decision in this regard shall be taken by the General Administration Department in consultation with the P.W.D.
